Thank you for your interest in being a Company Advisor (CA) for the 2026 summer Pennsylvania Free Enterprise Week program. Since PFEW's birth in 1979, over 54,000 students have participated in this handson experience to learn about business, teamwork, leadership, and other career and life skills. In addition, over 3,000 dedicated business volunteers have helped to create the life-changing experience that is *PFEW*!

As a CA, you will mentor a team of high school students and enhance your own leadership skills while you share your personal expertise and experiences.



Each week-long session blends the experience of returning CA's with the fresh perspectives and ideas of new Advisors (typically 20% are new Advisors each week). This commitment to be a mentor for a student team (15-18 students per team) brings a variety of opportunities to:

- o engage in intergenerational and *mentoring relationships* with future business leaders;
- o *network and share experiences* with other business professionals and establish life-long business connections;
- o enhance and practice your *leadership skills*, including those in communications, creative and critical thinking, team-building, and collaboration;
- o be a catalyst and contributor to life-changing experiences guaranteed to *impact students*;
- o allows an opportunity to *market individual jobs* and companies to the future workforce;
- o and, by the way have FUN!

The CA role is a professional development experience unlike any other. You will gain invaluable business insights and learn new techniques while at the same time practice your professional skills and expand your career and community leadership capacity. What is PFEW? Presented by the Foundation for Free Enterprise Education, PFEW is a unique and challenging program designed for incoming high school juniors and seniors. As a CA, you will spend a week on a college campus with other business volunteers from around the country as you help teens learn about business, teambuilding, leadership, and life skills. Over 54,000 students are now PFEW alumni and many testify to the change the week made in their lives thanks in part to their dedicated CA!

#### Company Advisor (CA) Role

As a CA you will mentor a team of 16 high school students. Teams work in a computer simulated environment to learn real life principles in finance, marketing, production, planning, project management and other aspects of modern business. Your role is to engage, educate and empower the students to be involved in the activities. The team will greatly benefit as you: share your experiences and expertise, ask engaging questions, and provide feedback on the team's involvement and interactions.

#### **CA Preparation**

A full day CA Introduction session will be held in late May for new CAs where a complete handbook will be distributed. On the **Saturday before each session**, all CAs for that week **must** attend the on-campus orientation to review program curriculum and corresponding CA responsibilities. Curriculum and the week's schedule are discussed, along with the business simulation. PFEW staff and returning Company Advisors are available to share their past experience and answer questions.

#### **CA Lodging**

Lodging at a hotel near campus is at the individual or their sponsoring company's expense. Discounted PFEW room blocks are available.

#### **Volunteer Expenses**

(NOTE: these are often reimbursed or paid for by your employer.)

- > Tues/Wed/Thurs. Night Dinners \$50 estimate. (Most Advisors go to dinner together. However, CAs are free to go to the Dining Hall these nights which is free of charge.)

### **Application Process**

Once you register, more information will be EMAILED to you at the address you provide on your CA Signup form.

PFEW conducts a full background check and child abuse clearances on all Company Advisors. Out of state residents and volunteers who have not lived in PA for the past 10 consecutive years will also be required to get FBI fingerprinting.

All Company Advisors must take the state-required online Mandated Reporter training prior to arrival at PFEW. Once complete, CAs must provide PFEW staff with the printed certificate of completion.

## **Additional Program Details:**

- Breakfast, lunch and dinner are provided each day.
- Company Advisors must attend the Orientation and teambuilding activities the Saturday prior to the program – start time is 8:45 a.m.
- Casual clothes (shorts, polo-shirts, etc.) are worn during the week,
   except at the Friday afternoon Awards Ceremony where business attire is appropriate.
- New Advisors will receive a PFEW polo shirt to wear on registration day and for company pictures. All returning Advisors are asked to bring their PFEW polo shirts with them from previous years. Shirts are available for any Advisor to purchase on the PFEW website at www.pfew.org/pfew-shirt-order.
- Daily programming begins at approximately 8:00 a.m. and ends each day around 9:00 p.m.
- Company Advisor meetings are held daily to facilitate day-to-day instructions and information sharing.

#### **Cancellations**

If for any reason you must cancel, please notify us as soon as possible so that we can work together to find a replacement. The role of the Company Advisor is the key to the success of the week and to our students' experience!

In 2026, all PFEW Sessions are held in Williamsport, PA at either Lycoming College or Pennsylvania College of Technology.
