Travis first worked at Sheetz during summers in high school and college, spending time in Store Development, Marketing, and Accounting. He graduated from Penn State University with a B.S. in Finance in 1992 and earned an MBA in Marketing from the Owen School of Management at Vanderbilt University in 1995. Upon graduation, he moved to Pittsburgh to become a Real Estate Site Selector for Sheetz in western PA and Ohio. He moved on to Director of Real Estate in 1998, and in 2001 began a rotation at Sheetz, serving as the Director of Sales, Regional Director of Operations, and Vice President of Operations. In 2013, he was named the Executive Vice President of Operations, overseeing Store Operations, Store Efficiencies, Maintenance, and Human Resources. In 2018, he was named the first President & COO in Sheetz history, and in 2022 he was named President & CEO.

Travis serves on the board of directors for QuikTrip, Sheetz, Inc., and Sheetz For the Kidz, an employee-driven charity serving children in need. He has previously served on the boards of various local organizations, including the Hollidaysburg Library, Hollidaysburg YMCA and Big Brothers/Big Sisters, and formerly served on the Board of Trustees for St. Francis University. He is active in the local youth sports community and has been a volunteer coach for numerous youth sports programs over the last 20 years. Travis and his wife Erica reside in Hollidaysburg, PA and they have four children: Max, Jenna, Ava, and Ella.

Prior to founding Omicelo, from 2009 to 2013, Joshua led US housing research for Goldman Sachs. He spent the previous five years as a critical member of Goldman Sachs' universal research team that found equity capital markets opportunities in the real estate, engineering, and construction industries.

During his time at Goldman Sachs, Joshua led research of a \$1 billion real estate IPO and received numerous awards, including an addition to Forbes' 30 under 30 list, as he was the youngest person in Goldman Sachs' history to lead an equity research practice. During the year between Goldman Sachs and founding Omicelo, Joshua built a psychology-based investment strategy to drive \$100 million of real estate capital investments for Pine River Capital Management in New York City.

In addition to chairing the board of Omicelo Cares, the education-based nonprofit affiliated with Omicelo, Joshua is a board member for companies that are building entrepreneurs, supporting communities, and creating a 21st century workforce. This community-enhancing work earned Joshua an invitation to the White House to receive the President's Volunteer Service Award among other awards and recognitions.
